2. *General objective*

To ensure the implementation of the Eastern Atlantic and Mediterranean JDP 2022, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex I of the implementing Decision (EU) 2018/1986.

3. *Summary of activity*

This report is a statistical snapshot of JDP activity between January and June (quarters 1+2).

In total, there were 327 inspections with apparent infringements reported out of 5358 inspections carried out at sea, 1307 inspections with apparent infringements reported out of 11845 inspections carried out ashore, and 2196 sightings from which 135 were reported with apparent infringements.
