## 2. General objective

To ensure the implementation of the Eastern Atlantic and Mediterranean JDP 2021, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex I of the implementing Decision (EU) 2018/1986.

## 3. Summary of activity

This report is a statistical snapshot of JDP activity between January and September (quarters 1+2+3).

In total, there were 638 inspections with apparent infringements reported out of 10071 inspections carried out at sea, 1684 inspections with apparent infringements reported out of 19689 inspections carried out ashore, and 3926 sightings from which 224 of them were reported with apparent infringements.
