2. General objective

To ensure the implementation of the Eastern Atlantic and Mediterranean JDP 2022, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex I of the implementing Decision (EU) 2018/1986.

3. Summary of activity

This report is a statistical snapshot of JDP activity between January and September (quarters 1+2+3).

In total, there were 480 inspections with apparent infringements reported out of 8188 inspections carried out at sea, 1852 inspections with apparent infringements reported out of 17413 inspections carried out ashore, and 3091 sightings from which 206 were reported with apparent infringements.
